

## First County Bank Foundation awards \$44,620 in grants to Norwalk nonprofits

In its continuing mission to give back to the communities of lower Fairfield County, the First County Bank Foundation recently announced the distribution of \$44,620 in grants to Norwalk-based nonprofits devoted to helping children and families cope with unemployment, housing and child safety.

Established in 2001 in honor of the bank's 150th anniversary, the First County Bank Foundation was created to distribute funds annually to nonprofit organizations that support community and economic development for children and families. As a mutual bank with no shareholders, First County Bank considers contributions made by the foundation a means of paying dividends back to the local communities it serves. Through 2009, the foundation has been able to award 343 grants totaling \$3.5 million to various community organizations.

"This tough economy has had a serious impact on many families in Fairfield County. As part of First County Bank's efforts to give back to the communities we serve, these grants represent a small portion of what's needed on a regular basis to help the people of Norwalk," said First County Bank Foundation Vice President Katherine Harris. "In fact, in our ongoing effort to expand the number of grant recipients, **this year marks the first time the foundation has donated money to Courage to Speak Foundation** and Norwalk Hospital Foundation," Harris added.

To be eligible, organizations must have nonprofit tax exempt status under section 501(c)(3) of the Internal Revenue Code; be located in Stamford, Darien, Greenwich, New Canaan, Norwalk or Westport; have community support; address community needs; have measurable outcomes; and demonstrate fiscal and administrative responsibility. Special consideration is given to those agencies or programs benefiting low to moderate income populations.

Although the deadline for applying for First County Bank Foundation grants has passed, a new short-form application, available April 1 until the end of the year, is available at [http://www.firstcounty.com/Foundation\\_Application\\_r3.pdf](http://www.firstcounty.com/Foundation_Application_r3.pdf). Short-form applications are defined as grants of \$2,500 or less for those applicants who fit the regular grant criteria, and \$1,000 or less for those applicants that do not fit the regular grant criteria.

The Norwalk Emergency Shelter is a not-for-profit organization located at 4 Merritt Street in Norwalk. Founded in 1983, it provides 95 + beds for homeless men, women and families. It also assist shelter residents in searching for housing, jobs, counseling and treatment, while seeking to foster independence and responsibility among its residents. Through Manna House, its soup kitchen, the Norwalk Emergency Shelter serves more than 12,579 meals a month. The shelter also provides free clothing and furniture to its clients.

The Child Guidance Center of Mid-Fairfield County offers a full-range of prevention, evaluation, and treatment services to address virtually every facet of a child's psychological, behavioral, and emotional health.

Norwalk Hospital Foundation
